## A Message from Cathy

It is now time for us to look back over the past year. In my case, it is only the last five months. Nonetheless, this is a time to reflect, learn and look to the future. These last few years have held great change for St. Andrew's. With staff turnovers in the administrative, custodial and ministry team complement, many adjustments have been made, which is difficult for any congregation. For some, it has been very challenging. In fact, I have sensed a hint of loss, even grief, from some of the parishioners I have visited with in these first few months. Yet, despite staff alterations, God calls us to move forward – hopefully learning from, and appreciating, the past, as we look toward settling into new ways of being the church in 2015!

A good deal of my time in the first few months at St. Andrew's has been spent getting to know my new colleague in ministry, Karen Lumley, as well as Andrea Moffatt (administrative staff) and key lay-leaders on the board. Many a day is filled with quiet, reflective work, team planning and hoots of laughter, as Karen, Andrea and I deal with the business of this charge. I have also greatly appreciated some wonderfully tender visits with matriarchs and patriarchs, as well as those who have simply stopped by the office to introduce themselves.

St. Andrew's is a bustling place within and beyond her walls! It is also a safe and sacred space that is used by both our church community and the community at large. This means that it is often hard to find a place to hold impromptu meetings or studies. This is a good thing - something to be celebrated. On a daily basis, Karen and I can often be seen hustling out the door to a visit, or to lead worship at one of the six senior residences or personal care homes in the area. The bible study groups are also a going concern, which any and all of you are invited to join. The hour and a bit of study is spent with the scriptures, which will shape the upcoming Sunday worship theme. Time is taken to explore some of the historic context, as well as what the text might mean for our lives in this time and place. Both of these groups offer a slower pace and opportunity to come into a deeper relationship with God, and those we are called to serve alongside.

As you look through your 2014 annual report, you will read about everything the congregation (collectively) has done over the past twelve months. I am sure you will agree that there is much to celebrate and be thankful for as a church community. I have witnessed a strong new beginning with stewardship, the building and painting of the new outdoor crèche, the stability of youth and family involvement in the Guatemala mission project and the hard work of the affirming group to draft a vision, mission and strategic plan to provide us with goals and direction for this upcoming year, to name just a few.

However, this is only a small snippet of my observations in these first few months. I have also been carefully observing, listening and assessing the congregational systems within leadership, worship, pastoral care, fellowship and finance groups. For instance, how does the church family communicate with each other and with the leadership team? What are the ministry priorities here at St. Andrew's? How do we use what we have? What is most valued? What do we dream about doing as a church? What are the ministry priorities, short term and long term, and how can a budgeting process be driven by our ministry and mission priorities? Could we narrow the focus of ministry and mission so staff and laity might have more opportunity for reflection, learning and spiritual growth? Finally, how does a building of this magnitude, help or hinder our call to serve others in need?

The affirming group has done some great work with a few of these questions. I would urge you to read through their insightful report, which may map out much of what St. Andrew's is about for the next three to five years, and beyond. Now is the time to consider how we will **live out** the proposed vision statement (*below*), after it is presented at the annual general meeting on February 22 following worship.

To live as Christ would have us live, in love, with compassion and seeking justice, by sharing God's grace, learning from scripture, growing through the Spirit and being transformed by faith.

Who will answer the many calls to ministry/mission, which are outlined in living out the overall vision statement proposed? How will the four priorities within the strategic focus *(italics/bold below)* listed for the first year of the vision be financed?

- 1. Using affirming language set up "basic training" for those who wish to learn about what is meant by "affirming language".
- 2. Expand the pool of involvement in church activities and/or worship services, e.g., scripture reading, music to be open to all.
- 3. Learn about "caring circles" in order to expand the pool of people who might assist the ministers in visitations or community contacts.
- 4. Establish an affirming symbol and include it in all public communications.

Have we budgeted for extra staff time, congregational training or planning time for these new priorities? Is the current congregation prepared to step up, and in some ways, out, when it will mean "major changes" to the delivery of pastoral care, worship and the many traditions held in great esteem here at St. Andrew's?

The congregation is being asked to vote on the overall vision, but we are also **pledging** to live out the mission based on the strategic plan being suggested. I pray you will take time to think through the positive possibilities this vision could bring, as well as the changes it

will mean. Karen and I wholeheartedly support the work of the affirming group and are excited about the new ways of being "church" this report recommends. Perhaps it is the time for us **all** to "be still and know, that I am God," so the vision of a few can be embraced by the many who call St. Andrew's home. I pray it is so, as we look to remember, celebrate and plan for the next 100 years, of being the church at the corner of Oak and Kingsway. May the Holy Spirit walk with us and direct our way forward.

#### From the Board Chair

The year 2015 marks the centennial of St. Andrew's River Heights United Church. The world has changed radically since our congregation built its first church at the corner of Oak Street and Kingsway Avenue in 1915. We have changed too – growing and adapting to the evolution of the society around us. Most important though, are the things that have not changed over this past 100 years. We continue to worship together and seek a deeper understanding of our faith. We reach out to the community around us and to the wider world with caring and concern. We support and encourage one another.

The year 2014 was a transitional time. In the first half of the year, while the Joint Search Committee was seeking a full-time minister to fill the vacant position, we were fortunate to have Judy Limpright serve as interim minister. In September, we were delighted to welcome Cathy Kinsman to our pastoral charge. At St. Andrew's, our two ministers function in a team ministry where they work collegially, having equal status, but with each having their own areas of expertise and responsibilities. Cathy focuses on Word, Sacrament and Pastoral Care and Karen focuses on Faith, Nurture, Pastoral Care and Outreach. In practice, there are many places where the roles overlap. As well, their skill bases are broad enough to cover for one another when the need arises.

We are blessed to have such a fantastic ministerial team! When I see Karen and Cathy interacting in meetings or informally in the office, I observe tremendous energy and excitement. They encourage and support each other with enthusiasm. These are two very gifted, highly trained, experienced, caring people who collaborate most effectively and who are passionate about their call to serve this pastoral charge. This is team ministry at its best.

In a very real way, we as members of the congregation are also a part of the team ministry. The special worship service that officially joins ministers to congregations in the United Church of Canada is called a covenanting service. The covenant we have with Cathy and Karen includes a promise we have made to join with them and support them in this ministry.

As is our pattern, 2014 was a busy year in the life of this congregation. The following is a partial list of issues that the board addressed in 2014:

- The affirming ministry group made significant strides in 2014.
- In mid-year, we developed an arrangement with the Hungarian United Church to hold their worship services in the chapel.
- We have enhanced the management of the Guatemala scholarship program through partnership with the Rotary Club and the Guatemalan Ministry of Education.

• We have taken the initial steps to participate in a multi-church program to support a refugee family from Syria.

When we look back at church records from the past, we find that there have always been financial challenges. I commented in the opening paragraph of this report that many things have not changed in our 100 years of existence; another of those things that hasn't changed is the perennial need for operating funds! I will leave financial reporting to the experts on the board whose detailed financial statements can be found elsewhere in this annual report, but I would like to thank all of you for your continued contributions – especially those who were able to respond to the fall stewardship appeal for increases in pledges.

I have been honoured to serve as your board chair this past year — a task made easier by the skill and dedication of the board members and the staff. The board members carry out their responsibilities with good cheer and great effectiveness. Our church staff is outstanding. As already noted, Cathy and Karen have formed an amazing team. Derek, Wes, Olivia and the choirs continue to provide inspired leadership in the ministry of music. Bill keeps the books and manages the flow of funds with incredible precision. We said farewell to Lou this past fall when he decided to retire after 10 years as caretaker and we welcomed Kirk to take his place. Through his familiarity with the building, Kirk was able to rapidly come up to speed in this position. Andrea, unfazed by short deadlines and the constant need for major multi-tasking, manages to keep everything humming in the church office and never hesitates to take action when she spots something that needs to be done. In any given week there are many volunteers performing all manner of tasks in this church. These important tasks are seldom given recognition, but would be sorely missed if they weren't done.

In 2015, we will celebrate our past as we observe our centennial, but we will also keep our eyes firmly fixed on the future as we launch ourselves into a second century of serving God in this place.

## **Chair of Finance Report**

"And whatever you do, work heartily, as for the Lord, and not for men, knowing that from the Lord you will receive the reward of the inheritance; for you serve the Lord Christ." Colossians 3:23-24 (ESV)

Our results for 2014 were very nearly on budget for most revenue and expense lines. We finished the year with a relatively small deficit as a result of one-time expense items. The details of our financial results are presented in the treasurer's report that follows. I believe our treasurer and board exercised good control of expenditures in 2014.

Our financial statements for the year ended December 31, 2014 have been reviewed by Frostiak & Leslie, Chartered Accountants.

We are projecting a nearly balanced budget for 2015. Based on pledges received, we project that congregational givings will be higher than last year and I wish to thank members of our congregation for their gifts to our church.

We are a very active Church with many outreach ministries. The support of all our missions has a financial cost. We are blessed to have a beautiful sanctuary in which to worship, and additional space for our many activities, but our building is 65 years old and requires continuous care.

As we celebrate our centennial year, there will be many opportunities to support the work of St. Andrew's with your gifts. I hope that you will consider discussing these opportunities with one of our ministers or a board member.

I would like to thank the members of the Finance Committee: David Bergman, Diane Bowles, Paul Webster, David Wreford, and our ministers Rev. Cathy and Rev. Karen. I particularly wish to recognize our Treasurer Bill Craddock for his dedication beyond the call of duty to controlling expenses and keeping our books in order.

# **Treasurer's Report**

It was a challenge this year to keep the Operating Account deficit to a minimum. Also, it was a very volatile year for managing our investments.

At the end of the year, while our deficit was greater than initially projected, it was less than we had been expecting through much of the year. This was in large part because of member offerings being \$3,709 over budget. This was due to some very much-appreciated extra member donations near year-end. Also, the change in caretaking hours resulted in a reduction in overall salary expenses.

We experienced unusual repair and maintenance expenses to our church building and equipment throughout the year. Repairs and maintenance were \$19,476 compared to a budget of \$8,000.

We ended the year with a deficit of \$14,442 in our Operating Account, which compared to the projected budget deficit of \$375.

In addition to the Operating Account, our church maintains a number of other accounts, which we label as Other Allocated Accounts. These accounts include all of the Guatemala missions, Anna Blair Circle, Right to Housing, and a number of others. In 2014, these accounts had total revenues of \$234,546 and expenses of \$181,157. Part of the revenue represents \$23,203 of bequests and gifts which became part of our investment portfolio. The year-end balances in these accounts are shown in Table 2.

Table 1 is the consolidated Income Statement for our Operating Account. Table 2 is the Balance Sheet for all of the church accounts.

Again in 2014, our daily financial operations of the church were very much dependant on our investment income. The foundation and church investments contributed a total of \$69,000 to the Operating Account.

I believe that all of our financial statements accurately portray our church's financial position at year-end, and that our accounting procedures are in good order. The independent review by the accounting firm Frostiak-Leslie will be available at the annual general meeting and later in the church office.

It has been a privilege and an honour to again serve as your church treasurer throughout the past year.

This summer for the first time in a number of years, we did not have to make any changes to our four section leaders. We are fortunate to have such gifted and dedicated leadership – Judith Oatway (sopranos), Diane Wreford (altos), Aaron Hutton (tenors) and Fred Cross (basses). Our four bursary recipients, Sarah Cory, Suzanne Reimer, Nathan Glowach and Nick Urquhart all returned as well. The bursary program has been very successful in supporting young talented singers, who provide gifted and inspiring solo performances as part of worship and enhance the sound of the choir as a whole. We also recognize that being part of the St Andrew's choir is often a stepping-stone in a musical journey, and it is not surprising that our vocal leaders will explore opportunities elsewhere to widen their musical experience and opportunities.

Derek Morphy continues to conduct our choir with great enthusiasm, humour and inspiration. He challenges us with an interesting mix of new choral pieces along with many of the more familiar gems, but perhaps with a varied musical arrangement. He always keeps us on our toes! The choir is pleased to enhance the worship experience with the presentation of inspirational music each Sunday through the church year and at other special occasions such as the Good Friday Service and Christmas Eve Service. Our organist, Wes Elias, is a very talented musician and accompanist. We at St. Andrew's are blessed to hear him play each and every Sunday, as well as other occasions. Thank-you, Wes, for all your hard work in preparation for the weekly choir practices and Sunday Services.

The hand bell choir has continued to enchant the congregation at various worship services during the year, and we are very grateful for the leadership that Olivia Arnason provides in preparing the "ringers" for their performances.

From time to time, guest instrumentalists join the choir, and the entire Sunday school joining the choir to present a Tanzanian folk song as that Sunday's anthem enhanced one notable November service.

# Affirming Group Report

The ministers have acted as a resource to the group. In addition, input for the journey was obtained from Patrick Woodbeck, Ted Dodd, Nancy Sanders, Bruce Faurshou, Lorraine Mackenzie-Shepard and Paul Campbell. Presenters to and from the congregation included: Hartley Stinson, Alenna Mark, Jack Maier and Dolores Jardine. The group has met for the past 2½ years taking this congregation on the journey toward becoming an affirming ministry. You, as a congregation, were involved in and invited to provide input a number of times over that period of time. By October 2014, we were able to draft our final submission to Affirm United, the organization, which approves all congregations wishing to become an affirming ministry.

Affirm United approved all aspects of our submission. However, two remaining requirements exist in order for our congregation to officially become an affirming ministry:

- That the proposal is voted on at an AGM/congregational meeting and passed with a 75% majority by both members and adherents.
- That a celebration is held to make a public statement that we have completed the first part of the affirming journey and a commitment that the journey will continue.

Please note that there is also a new vision/mission statement, which can be found on page 2 of this annual report. Heather Quinn presented this to the congregation in October and invited your feedback.

The board reviewed the document in October before it was submitted to Affirm United. As required by our constitution we now present it to all of you (3 weeks in advance of the meeting) and hope to bring it to a vote at the AGM in February.

The group is very pleased to be able to present the results of the journey to you at this time. We pray for God's guidance as we consider this momentous decision.

St. Andrew's is a proud sponsor of this event and the Fellowship Committee assisted in the preparation of the food. Over \$11,000.00 was raised and all proceeds and over 50 jars of peanut butter were donated to the Agape Table. Excellent work Karen! Doreen Craddock coordinated the harvest supper once again and this event was held on October 5, 2014. # **Ministry and Personnel Report**

The Ministry & Personnel Committee is a confidential consultative body that supports the pastoral relationship. In the United Church, we describe ourselves as "being in ministry together", recognizing that the work of the paid ministry personnel is only part of the work of the ministry. There are also a number of other staff positions for which the M&P Committee is responsible including the office manager, caretaker, choir director, organist and financial administrator.

#### Duties of the M&P Committee include:

- Provide a consultative and supportive agency
- Review working conditions and remuneration
- Oversee the relationship of staff members among themselves and with the congregation
- Conduct annual staff evaluations
- Review regularly the responsibilities of staff and revise position descriptions when required
- Monitor continuing education

As a committee we have three main areas of responsibility: administration, personnel and ministry.

#### **Administration**

Andrea Moffatt, our office manager, is responsible for organizing, coordinating, and supervising office operations and procedures. Using our ChurchWatch software program as well as other programs, Andrea is able to track membership, manage calendars, coordinate events and facility management and maintain an email database that enables electronic communication with our congregation and community partners. This past year Andrea has also developed our new website and updated our computer software. Her office hours are Monday to Friday, 9:00 am to 3:00 pm.

## <u>Personnel</u>

We continue to be supported by a group of talented and dedicated staff members. Music is one of the cornerstones of our congregation. We are truly blessed to have the talents of our senior choir led by Derek Morphy and organist Wes Elias.

After 12 years as caretaker, Lou Jubinville announced his retirement at the end of October 2014. Lou did a wonderful job maintaining our church to its original character and appearance. No easy task for a facility built in 1950 and in constant use. In November, we welcomed Kirk MacDonald as our new caretaker.

As financial administrator, treasurer and reporting to the Finance Committee, Bill Craddock manages the financial affairs of St. Andrew's. For 38 years Bill has served on many committees including the board.

This past year the M&P Committee conducted evaluations on all staff members. These annual reviews allow ministry personnel, staff members and various groups and committees of the congregation to support one another in their mutual responsibilities for ministry. There was both written and oral feedback. These reviews ensure proper functioning among all parties and in some cases identify areas for professional development. Our committee also monitors and, where necessary, adjusts position descriptions that accurately reflect areas of responsibility and accountability for all staff.

#### **Ministry**

In September 2014 we welcomed the Reverend Cathy Kinsman to the ministry at St. Andrew's. In a team ministry with Karen Lumley they both support the mission of St. Andrews. This is accomplished by their two distinct roles. Cathy's priorities are worship with a focus on preaching and sacraments in addition to pastoral care and adult education. Karen's focus is Christian education, youth programs, outreach, and pastoral care. We are very fortunate to have two highly respected and gifted individuals ministering in our community.

# **Outreach Report**

Overall, St. Andrew's continues to have a very active outreach program, and this past year was no exception. We support several ministries including: Sage House, Safe Passage, Winnipeg Harvest, West Broadway Community ministry, Siloam Mission, Rainbow Ministry, Agape Table and St. Matthew's Maryland ministry. Some details are listed below.

In January 2014, we took part in the *Let's Talk Turkey* event in which we cooked and delivered several turkeys to the Oak Table Program at Augustine United Church.

In February 2014, we supported the *S.N.O.W* event (Safe Night Off Winnipeg streets) that offers support in a non-judgemental manner for women who are involved in the sex trade.

In September 2014, St. Andrew's under the leadership of Karen Carswell supported the *Hustle for Hunger* event; proceeds went to Agape Table. St. Andrew's supports this event through those who come out to walk, make a pledge and very importantly through the Fellowship and Pastoral Care Committee who prepare a breakfast & help with the planning.

At our November 2014 meeting, several motions were passed which allowed monies to be given to Winnipeg Harvest, Siloam Mission, 1Hope Winnipeg and Agape Table.

From November – February, other projects that were ongoing were: *Hoodies for the Homeless*, *Fit Feet on the Street* and the *Warm Socks* appeal.

In December 2014, the mitten tree appeared in the narthex once again, receiving warm accessories knitted or purchased. These wonderful items were distributed to the outreach ministries in the city represented by 1Hope Winnipeg.

A new challenge was embarked upon in the early fall of 2014. With the approval of the board, St. Andrew's joined forces with *Refuge Group Winnipeg* to take part in a refugee sponsorship opportunity. *Refuge Group,* comprised of more than twelve churches and community affiliations, is a local group that has been approved by the Canadian government to sponsor three refugee families (all three of the men are brothers) from Syria to be reunited with their sister's family here in Winnipeg.

St. Andrew's has been given the opportunity to assist in the project, through donations and/or through working on projects to help settle and maintain the families once they arrive in Canada. This project is one way for the church to put faith into action; to make a difference for real people affected in a war-torn country.

Two other extremely important aspects of St. Andrew's outreach program are: the Meals on Wheels program and the Right-to-Housing Coalition capably lead by Ardelia & Bruce Burrow and Clark Brownlee respectively. More details can be found in their respective reports elsewhere in this AGM booklet.

Thank-you to all of the volunteers that participate in the St. Andrew's outreach projects throughout the year.

## Right to Housing - an Aspect of St. Andrew's Outreach:

Right to Housing Coalition, (R2H), is a volunteer housing advocacy coalition made up of a variety of retired and employed volunteers, and fifty supporting organizations, of which St. Andrews is one. R2H had its origins ten years ago when St. Andrew's was one of the faith communities that, together, tried to get some of the then empty houses on Kapyong military base to house newcomers to Winnipeg. Many things have changed since then, but the need for more social and affordable housing for Canadians is not one of them. Another thing that hasn't changed is St. Andrew's ongoing support. Amongst other things, St. Andrew's handles our finances, which not while large, are necessary for our work.

The housing shortage can be traced to a series of policies by governments at all levels. In response R2H has created working groups that target policies at the federal, provincial and municipal levels. Our advocacy works include presenting briefs, speaking to interested groups, using the media and lobbying politicians and public servants about the need for changes in housing policies. This is slow work as we are aware that the current political system is always short of the financial resources it would need to do everything that demands attention. Recognizing this, our work is to raise housing for low-income Canadians on the political priority scale. This year, after countless meetings and interventions I can say that there has been some progress.

The encouraging signs include a promising climate change between the City of Winnipeg and the provincial government regarding the sharing of housing solutions in Winnipeg, a long time objective of ours. The provincial vacancy rates for rental housing are creeping up, showing that Manitoba's initiatives to create more social and affordable housing are having a positive impact. There are also positive signs that the problem of homelessness in Winnipeg will be dealt with in a more coordinated way as the Province of Manitoba, the City of Winnipeg and the United Way have committed funding to the "Plan to End Homelessness in Winnipeg" for the coming years.

So far the federal government has not been responsive to our message. This is a significant issue as the federal government controls the policies of Canada Mortgage and Housing Corporation, which until 1993 reinvested its billions of dollars of profit into creating low-

income housing. Since that time, it has directed these profits into its own revenue, only a small percentage of which is reinvested in housing.

Thank-you to the people St. Andrew's for your continued support and encouragement.

# FunJesus Guatemala:

St. Andrew's has been one of the key sponsors of FunJesus for the past 6 Years. This very special home is for children that the courts see as the worst cases of child abuse. Children in desperate need of love, consistent support and a family atmosphere provided in the home, which Vanessa Gonzales has been operating for 14 years. It has now grown to 32 children. She originally only took in babies that were in prison, or born in prison, with their mothers. The courts, after seeing positive results, had, in most cases, kept the children at FunJesus after the mothers were released. An interesting observation to me was that when the mothers were released, and visited the home to see their children, they told Vanessa the children had a much better life and opportunity than they could provide. They left them in her care but keep limited contact, and the children tell me they have two moms.

Four of the original girls have had successes in University – Maylin graduated as a culinary professional this year, and is now working as a chef in a large restaurant in Guatemala; Amy will be graduating in 4 months as a graphic designer, and has been top in her class for the past three years; and the other two are working on completing degrees in accounting and sports therapy.

For Maxine and myself, as regular visitors to the home, the gift has been far greater than I could ever have imagined. I have seen children, who were born into the worst imaginable situations and abused in ways I can't comprehend, turn into spirit-filled children living a safe life filled with hope and opportunity.

Forgiveness has released these children from their past, which I feel most people, including me, would have trouble doing. Love has transformed them, giving them a life filled with opportunity to dream and flourish.

# **Property and Administration Report**

The calendar year 2014 was not a high point in the life of the P&A Committee. We had our share of unexpected maintenance issues and, with our aging infrastructure, it is unlikely that we have seen the last of these.

In the category "maintenance and repair," the financial records show two major items: regular "repairs and maintenance" and "major maintenance". The second of these, "major

maintenance," covers significant projects that are planned well in advance and budgeted for at the beginning of the year. These don't happen every year but for 2014 it was decided that the sloped roof over the eastern side of the CE building had deteriorated to the point where replacement should not be delayed. This job was budgeted at \$18,000 and came in slightly above that, at \$20,200.

It was in the regular "maintenance and repair" item that we encountered several unanticipated and unpleasant surprises, mostly connected with the boiler and heating system, for example the need to replace the main air blower motor on the boiler when the heating system was activated in the fall. As well, a heat exchanger in the incoming air duct in the sub-basement was found to be leaking badly. It had to be repaired and, partly due to its inaccessible location, the job was costly. Not all of the additional expenses were related to repairs. Some involved heating system control modifications that are expected to lower future heating costs.

Other unexpected problems, ranging from a mouse invasion in the CE wing to lighting issues in the sanctuary and elsewhere added to maintenance costs with the result that regular "maintenance and repair" costs ended up at \$19,500 instead of the budgeted \$8,000. In addition, the elevator control panel had to be replaced, and snow-hauling expenses (to clear parking areas in the back lane) were well above budget due to the unusually snowy winter of 2013/14. (These latter two items are accounted for separately in the financial records.)

Looking ahead, major projects needing to be tackled in the foreseeable future include replacement of the flat roof over the western side of the CE wing, major repairs to (or replacement of) the narthex flat roof, replacement of the large windows behind the balcony, major repairs to (or replacement of) the southwest entry steps to the narthex, repointing of much of the exterior stonework and window ledges, installation of additional electrical lines into auditorium service boxes, and replacement of the sanctuary's red carpet, which is looking increasingly shabby. Longer-term, the entire heating system with its network of aging radiators, steam pipes, steam traps and return condensate lines will need substantial renovation. Much of this equipment is now 60 years old. While the boiler was replaced relatively recently, the rest of the system is original. The committee feels that attention must soon be given to the means of financing this work, with the possibilities including one-time special appeals (for the sanctuary carpet, for example) and the establishment of a financial reserve to cover future costs of replacing major components of the heating and ventilation systems.

On the personnel front in 2014, we said farewell to Lou Jubinville upon his retirement in the fall, and welcomed his replacement, Kirk MacDonald. Kirk is working fewer hours than Lou did, though he is in the building on all five weekdays rather than just four. He does not

perform the daily boiler check during the heating season, as this task requires fifth class engineering certification. An external contractor now handles that responsibility. As well, Kirk's reduced hours mean that he is not always available for unscheduled jobs such as set-up for major events in the auditorium. It is expected that congregational volunteers will fill this gap, as in fact they already do to some extent at St. Andrew's and many other churches. The net result of these changes (as can be seen in the budget numbers) is a reduction in caretaking salaries that more than offsets the additional contracting fees.

During the year, the committee continued with a full complement of members: Murray Cameron, Bruce Scott, Gord Shawcross, Hartley Stinson, John Swan, Susan Wiste and Dave Wreford, along with our ministers Cathy Kinsman and Karen Lumley. As usual we single out Gord and Hartley for all their hands-on work, respectively, on internal maintenance issues and external contracts. We also thank Murray, Bruce, John, Susan, Cathy and Karen for their invaluable input and assistance. Last but not least, we thank Kirk MacDonald for so ably stepping into the janitorial shoes, and taking on so willingly the responsibilities of that challenging and occasionally frustrating job.

Finally, we recognize the work over many years of Lou Jubinville in contributing to the smooth operation of the building, and wish him a relaxed and enjoyable retirement.

# **Stewardship Report**

# For where your treasure is, there your heart will be also. Matthew 6:19-21

A joint discussion group including both the Nominating and Stewardship committees was held on June 2, 2014. This meeting provided an opportunity to reflect on the meaning and purpose of stewardship at St. Andrew's, and inspired the Stewardship Committee for their work ahead.

During this meeting, Linda Paul presented a resource book, *Bounty: Ten Ways to Increase Giving at Your Church* by Kristine Miller & Scott McKenzie that became the underpinning for committee planning. In addition, the United Church website, <a href="https://www.stewardshiptoolkit.ca">www.stewardshiptoolkit.ca</a> provided excellent resources as well.

After a committee meeting in July, Lorilee decided to volunteer to act as chair and attended the August board meeting to meet the board and provide an overview of the committee's short and long term planning.

A description of the basic tenants of stewardship was added to the stewardship link on the newly revised St. Andrew's website.

The motivating beliefs and goals of the committee work this year were:

- Stewardship is a journey that is grounded in gratitude, revealed in prayer, lived in faith. (Bounty)
- Grow toward all-year-round stewardship.
- Focus on the blessings we receive because of our relationship with God and St. Andrew's, our gratitude, and the ways our generosity impacts the lives of others.

The theme of our annual pledge campaign in the Fall was "Loving God with our Gratitude, Loving Others with our Generosity", and it included the following components:

- Lorilee led a discussion and activity regarding the concepts of stewardship with the youth during one of their classes in September.
- Youth created a large theme poster and provided posters and assistance for the gratitude sticky note worship activity.
- "Stewardship Seconds" were added to the weekly bulletins, and will be included year round.
- "St. Andrew's by the Numbers" bulletin inserts were created and included for 3 Sundays during the campaign. These lists highlighted the impact of St. Andrew's faithful stewardship practices.
- "Stewardship Minutes" provided by congregation members of all ages commenced during the campaign and will continue throughout the year.
- Campaign updates were communicated during announcement time, the bulletin and the weekly e-blasts.
- Thanksgiving Sunday: gratitude sticky note activity involving all congregation members. Karen completed the activity with younger members during their gathering time downstairs.
- Revision and updating of the campaign pledge letter.

# Winnipeg Presbytery – Highlights of 2014

**February** – Our general meeting was an all-day meeting that was held at The United Church in Meadowood. The co-hosts of the meeting were Trinity United Church, Charleswood United Church, Westminster United Church, McClure United Church and Oak Table Community Ministry. A presentation was made on social media and how the church needs to become involved in this technology. Caryn Douglas gave a presentation on an apology to disjoined deaconesses and married ordained women. Group table discussion regarding the theology of the church – exploring the differences and similarities in our hope for the Presbytery – took place.

March – The general meeting was held at Atlantic-Garden City United Church with co-hosts of the meeting being Sparling United Church, Kildonan United Church and Fred Douglas Lodge. The discussion paper 'Fishing on the Other Side' from General Council was discussed. The Presbytery was divided into four discussion groups to discuss the four topics of the document (connectional space, property, oversight of communities of faith and oversight of ministers). Everyone gathered afterward to discuss the overall opinion of the discussion paper. The results were then forwarded to General Council.

**April** – Our general meeting was held at Windsor Park United Church with co-hosts of the meeting being Transcona Memorial United Church, Grey Street United Church and Rainbow Ministry. Patrick Woodbeck, the Rainbow minister, led everyone in an exercise using non-gendered language. Winnipeg Presbytery approved the hiring of a fund developer for 1Hope Winnipeg. The following were approved as Commissioners to General Council 42 in August, 2015: Tim Crouch with Jeff Cook and Bill Millar as alternates (ordered ministry); Patrick Woodbeck with Ruth Denton as alternate (lay commissioner).

May – The general meeting was held at Crestview United Church with co-hosts of the meeting being Kirkfield Park United Church, Sturgeon Creek United Church, Silver Heights United Church and St. Charles United/Headingley United Church. As proposed by CDI, Winnipeg Presbytery approved the establishment of the Winnipeg Presbytery Christian Service Fund (for projects and programs that are intended to improve quality of life for disadvantaged persons in Winnipeg) and the **Pastoral** Development/Redevelopment Fund (to provide grants and loans for activities intended directly or indirectly to create new pastoral changes or increase membership of existing pastoral charges in Winnipeg). These two funds were created by combining other funds into a single fund.

June – Our general meeting was held at St. Mary's Road United Church with co-hosts of the meeting being Churchill Park United Church, Korean United Church, Hungarian United Church and St. Matthew's-Maryland Community Ministry. Deborah Murray was installed as the new chair of the Presbytery. The opening worship included a covenanting service

for the incoming executive. The Presbytery approved the policy for grants from the newly established Pastoral Charge Development/Redevelopment Fund. Approval was also given for the policy for loans from funds administered by CDI. The Nominating Committee report for 2014-2015 was presented and approved. Richard Manley-Tannis gave an update on the progress of 1Hope Winnipeg.

**September** – The general meeting was held at Broadway Disciples United Church with cohosts Knox United Church, Young United Church, Chinese United Church, Augustine United Church and West Broadway Community Ministry. Members of Knox United Church led the opening worship. Ha Na Park, the new teammate in ministry with Gordon Taylor at The United Church in Meadowood and Min-Goo Kang, the new minister from Fort Garry United Church, were introduced. Patrick Woodbeck presented a short video presentation on a transgender child and the "genderbread" person, which highlighted gender identity, gender expression, biological sex and sexual orientation. Tessa Blaikie, the new 1Hope Winnipeg Fund Developer, was introduced and welcomed.

**October** – Our general meeting was held at Westworth United Church with co-hosts Harrow United Church, Fort Garry United Church and Crescent Fort Rouge United Church. E-ministries highlighted the Appreciative Inquiry (AI) workshop that was being planned and encouraged everyone to attend. Mary Best gave an overview of the new compensation model that will be implemented July 1, 2015. The 2015 mission support grants were approved.

**November** – The general meeting was held at Windsor Park United Church with co-hosts Transcona Memorial United Church, Grey Street United Church, Westminster United Church and Rainbow Ministry. The 2015 Draft Budget was approved. Cole Grambo gave a report on the work and initiatives of Spirit Path United.

# Farmers' Market

It's hard to believe the River Heights Farmers' Market is five years old. What started out as a farmer-less market on a rainy Friday afternoon has grown into a Friday afternoon destination in our neighbourhood. This year was a year of growth and change for the market in regard to our vendors and our internal organization.

#### Our Team

The market is a team effort, and it benefits by the variety of team players that make it work. We would first like to thank the Central Corydon Community Centre for all the work they do to keep us going. Thank-you to all our vendors who bring their goods to the market faithfully and have worked so hard to please our customers. Thank-you to our Friday 'clickers' who greet our customers and keep a tally of the day. Thank-you to St. Andrew's River Heights United Church for their support. And finally, Thank-you to our loyal customers. We love serving you and seeing you each week.

### Growth, Changes and Challenges in 2014

- Our market is still a friendly, welcoming place for families and visitors to purchase quality, locally grown or crafted goods.
- All of our farmers from 2013 returned for all or part of the 2014 season, and we added one large baking/farming business to the mix.
- New vendors continue to be attracted to the market; however, most of our new contacts this year did not want to attend regularly or they needed electricity for their stall. In addition, we lost a few smaller, regular vendors from last year.
- The weather always presents challenges to farmers, bakers, and crafters. With the cold winter that we had, all the crops were delayed. Hence the market got off to a slow start.
- There are now 4 large markets in the downtown area located at: The Forks, Exchange District, Broadway, and the Hydro Building. While we did not notice a significant decrease in our customer base during July and August, there was a decrease in the number of vendors attending our market and the number of new vendors requesting to join the market (see 'Visitor and Vendor Count').
- Alas, two of our advertising signs that were placed on Corydon Ave went missing in September.
- Finally, Stephanie Sopher was communication coordinator and Barbara Coombs was Site Coordinator this year. We also enlisted the aid of two other site

coordinators, Luba Scott and Ruth McKenzie who were great helpers handling the weekly setup and take down.

# **Ideas and Developments for 2015**

- The lack of permanent electrical outlets is a concern for future growth; however, this is likely to be solved next summer. The Boy Scouts annual Christmas tree sale was relocated to the same area of the community centre's parking lot as where the market is held in the summer. The scouts require electricity for their sale; therefore, they are looking into installing permanent electrical outlets in that area. We will, of course, help with this cost.
- We have learned the other markets offer honorariums, or at least gas money to offset transportation, to buskers. It would be great to have someone from our local music community to organize the busker schedule for 2015.
- After much thought and consideration, both Barbara and Stephanie will be retiring from the market in 2015. It has been both a pleasure and an honour for us to serve the vendors, volunteers and visitors at the market. However, we are very pleased to announce that the Central Corydon Community Centre will be taking over the organization and coordination of the market for 2015 on a trial basis. St. Andrew's River Heights United Church will still supply some volunteer help. More details on this will be coming as the 2015 season approaches.

We continue to reach out, as well as advertise, through Facebook and Twitter.



# St. Andrew's River Heights United Church Foundation Report

The St. Andrew's River Heights United Church Foundation was established in 1975. The foundation was initially funded with funds derived from special gifts and the sale of the church manses. Since its inception the foundation's assets have grown as a result of bequests, memorial gifts and donations. A minimum of 80% of the annual and/or accrued income derived from the foundation is distributed annually to St. Andrew's United Church to be employed in the ongoing mission and work of the church.

The foundation has been primarily invested in fixed-income investments such as money market funds, bonds and deposit notes. As at December 31, 2014, 64% of the market value of the foundation's assets were invested in fixed income or equivalent investments (comprising guaranteed investment certificates and provincial, municipal and corporate bonds ranging in duration from 1 to 7 years and preferred shares) and 34% was invested in equity mutual funds, common stocks, real estate trust units (primarily comprising large-cap Canadian companies, US and international growth and dividend funds and a Canadian real estate investment trust). The balance (approximately 2%) was held in cash.

Over the past number of years, due to its relatively high percentage of fixed income investments, the foundation's balance sheet and rate of return have been quite stable. The table below indicates the *approximate* market value of the Foundation \* (inclusive of accrued interest) as at December 31 in each of the following years:

2010	\$789,000
2011	\$815,000
2012	\$864,000
2013	\$886,000
2014	\$899,000

Although the market value of the foundation has been increasing, the income earned by investments has been declining due to an ongoing low fixed interest rate environment. For the past three years the foundation has crystallized some capital gains upon the disposition of several investments that had appreciated in value. In the 2014 year the foundation continued to move a larger portion of investments from bonds into preferred shares and large cap equities in an effort to improve yield as well as the underlying growth on the portfolio.

The foundation's investment advisors (CIBC Wood Gundy) have confirmed that the annualized rates of return for the foundation investment portfolio as at December 31st, 2014 were as follows:

From 1998 to 12-2014	5.798%
01-2010 to 12-2014 (5 year)	6.269%
01-2012 to 12-2014 (3 year)	6.631%
01-2014 – 12-2014 (1 year)	6.489%

During the 2014 calendar year, foundation investments earned interest and dividend income of approximately \$37,000.00. From this income the foundation contributed \$40,000.00 to the operation of St. Andrew's Church during the 2014 calendar year. These contributions were paid during June and in early December 2014. During the 2015 calendar year the foundation projects earnings of slightly over \$37,000.00. The slight increase in income comes at the risk of moving some assets from bonds to preferred shares and large cap equities, which provide a higher yield than current bond yields. At the foundation annual meeting held in November of 2014, the board committed to make a gift of \$45,000.00 to the operation of the St. Andrew's during the 2015 calendar year. Audit costs and income tax filing costs for 2014 (payable in 2015) are anticipated to be in the neighbourhood of \$3,500.00 plus taxes.

The specific gifts received by the foundation during 2014 are set forth in Schedule 'A' to this foundation annual report, but were in the total amount of \$8,975.00.

Once again, the foundation expresses sincere thanks to all who gave so generously to the foundation during the 2014 calendar year. As chair, I would encourage all members of the church to make annual contributions to the foundation and I would challenge all members to consider their part in attempting to increase the value of the foundation assets to 1 million dollars over the course of the next year. Our goal this year to celebrate the church's 100<sup>th</sup> anniversary is to cross the 1 million dollar mark.

As chair of the board of the foundation I wish to thank all the members of the board for their valuable assistance. Again, this year, I wish to express thanks for the tireless efforts and contributions of David Wreford as secretary of the foundation and to thank Mark Braun of CIBC Wood Gundy for his investment counsel.

The foundation wishes to encourage members of St. Andrew's United Church and other individuals or organizations who utilize the church building for the advancement of community objectives and activities, to make a donation to the foundation. All gifts to the foundation receive a charitable donation tax receipt, which reduces the out-of-pocket cost of the gift. It is particularly useful in estate planning to consider gifting registered investments such as an RRSP or RRIF to a charity (if such investments are not eligible to be 'rolled over' to a surviving spouse as beneficiary). In situations where the registered investment cannot be gifted or 'rolled over' to a surviving spouse, the donor's estate will receive a significant reduction in tax that would otherwise be payable to Canada Revenue Agency upon collapse of the registered investment. Money that would otherwise go to

Canada Revenue Agency may thereby find its way into the Foundation to serve the broader purposes of the foundation and the church. Please speak with your investment advisor, accountant or lawyer for more information in planning your charitable estate gifts. Your gifts enable the foundation to contribute financially to the ability of St. Andrew's River Heights United Church to serve both the community of faith within the church and the broader outreach work of The United Church of Canada. Gifts to the foundation truly are gifts that 'keep on giving' - while you are alive and after you have departed this world. The foundation encourages gifts made at any time during your lifetime or as a charitable bequest under your will.   - Bill Craddock commented that the decision to reduce the Mission & Service Givings from 7.5 % to 6% was made given the fact that 'other' Outreach Fund Donations to M&S regularly amount to approximately \$100,000 each year.

#### c. **2014 Budget**

**Moved**: Paul Webster/Deborah Metcalfe that the Congregation accepts the 2014 Operating Budget as presented and discussed. **Carried** 

- Paul Webster closed his remarks by thanking the committee for their diligence and hard work as well as by stating that he is stepping down as Chair of the Finance Committee.
- **9. Constitutional Amendments/Policies** Linda Paul gave a rationale for presenting three proposed amendments to the Constitution.

#### a. Amendments to the Constitution Article IV:

(1) #2. b, vii "A two year interval is required before a retiring Board member can be re-nominated to the Board."

The proposed amendment will read as follows:

A two-year interval is required before a retiring Board member can be re-nominated to the Board. This requirement does not apply to the position to Vice-Chair and Chair.

(2) #4. Elections "Members of the Board are elected at the Annual General meeting of the congregations held for that purpose."

The proposed amendment will read as follows:

Members of the Board are elected at the Annual General meeting of the Congregation held for that purpose. In the event that a position is not filled Article IV #10 would apply.

(3) #10. Vacancies "In the event of the death, resignation or transfer from membership in the congregation, the Board may appoint a member or adherent of the congregation to fill the vacancy on the Board until the next Annual General Meeting for election to the Board."

The proposed amendment will read as follows:

In the event of the death, resignation or transfer from membership in the congregation, or in the event that a position was not filled at the Annual General Meeting, the Board may appoint a member or adherent of the congregation to fill the vacancy on the Board until the next Annual General Meeting for election to the Board.

**Moved:** Bill Craddock/Paul Webster that all three of the above constitutional amendments are accepted as presented. **Carried** 

<u>Discussion</u>: Barbara Coombs commented that the intent of the original #10 statement was to encourage new blood on the Board. Clark Brownlee spoke in favour of the motion by indicating that the amendment allowed for Board members to gain valuable experience through sitting on the Board prior to stepping into the positions of either Vice-Chair or Chair.

b. <u>Fundraising/Revenue Generating Policy</u>. A copy of The Fundraising/Revenue Generating Policy was distributed to those present. Linda Paul spoke to the background on 'serving alcohol' as well as on 'gambling' at St. Andrew's.

#### **APPENDIX B**

# St. Andrew's River Heights United Church Constitutional Amendments February 2014

#### **Article IV**

9. Composition of Committees (2011)

Board members shall chair no more than one Standing Committee, nor will they sit as chair of one Standing Committee and as one of the designated representatives to Presbytery.

#### **Proposed Amendment 2014**

Board members shall chair no more than one Standing Committee, nor will they sit as chair of one Standing Committee and as the Designated Board Representative to Presbytery.

#### Article VII

1. Composition and Term (2011)

The Board of Trustees shall consist of three members elected by the congregation. The term of office shall continue until terminated by withdrawal of membership in the congregation, resignation, retirement, death, or by removal by the congregation. Vacancies on the Board of Trustees shall be filled by the congregation at the next Annual Meeting or at a special congregational meeting called for that purpose. Members retiring shall remain in office with full authority until their replacement at the next congregational meeting.

#### **Proposed Amendment (2014)**

The Board of Trustees shall consist of a minimum of three and a maximum of seven members elected by the congregation. The Board of Trustees will meet a minimum of once a year.

The term of office shall continue until terminated by withdrawal of membership in the congregation, resignation, retirement, death, or by removal by the congregation. Vacancies on the Board of Trustees shall be filled by the congregation at the next Annual Meeting or at a special congregational meeting called for that purpose. Members retiring shall remain in office with full authority until their replacement at the next congregational meeting.

Note: The Manual of the UC of Canada indicates that there can be a maximum of 15 members. Note also: One of the following people is automatically a trustee because of their position: (a) the member (or one of the members) of the order of ministry who has been settled in or appointed to the pastoral charge.
