

### A Message from Cathy

It's been an interesting year. For me, facilitating small group experiences in spiritual formation never gets old. Seeing more congregational folks seeking to deepen their faith and walk with God, is both humbling and inspiring. It's exciting to pray, listen, "be," envision, and dialogue about possibilities that lie ahead for the people who call St. Andrew's home. To see these small groups double in size over this year has been a great gift which has moved folks to lead and discern possibilities within their gifts and continued ministry. Keep in mind, God calls us to faith and faith requires risk, but what that involves isn't always clear. These small groups are helping to provide a sense of direction as we live into our vision. Gratefully, we have a vision statement – something we aspire to. I do sense; however, the steps to lead us into that vision are unclear. In case you have forgotten or didn't know, our vision statement reads like this;

To live as Christ would have us live, in love, with compassion and seeking justice, by sharing God's grace, learning from scripture, growing through the Spirit and being transformed by faith.

This is quite a vision statement which I continue to bring before you, in worship and smaller groups. Are we living the way Christ would have us live? Are we sharing God's grace? Are we learning from scripture? Are we growing through the Spirit and being transformed by faith? If so, how? The report before you speaks to the many goings on here at St. Andrew's. Perhaps everything enclosed in this annual report is proof we are growing into the vision? I'm not sure. God has walked with us in much of this last year, as you will read. I encourage you to discern if the "goings on" support our vision.

The year 2017 began with several deaths of long-standing members. Lives were remembered and celebrated, with family coming "home" to St. Andrew's, to be comforted and supported in their times of grief. We closed the year in a similar fashion providing touching musical remembrances for parishioners who have contributed to the care and musicianship of the church.

Throughout the year, we have been challenged to learn about several remits before us from the National Church regarding structure, ministry (one stream) and geographical boundaries. Information was presented to the congregation through the bulletins and e-blast. The Service team, along with a few congregational members cast our votes on the remits. We will see how these votes take shape with the National General Council meetings happening this summer in Oshawa Ontario.

Sunday morning worship has continued to transform and evolve at St. Andrew's. Making a joyful noise together as we worship God is something St. Andrew's does well. A new bulletin format rolled out in September has been well received. The younger members say, "it's easy to read - really tells everybody what we are all about," and "wow, I didn't' know we did all that here!" As we strive to remain true to tradition, we are also looking for new ways to grow in faith and number, encouraging people to be curious about faith and how we are living it out in the world. To that end, Margaret Pratt hosted a coffee time after worship in the fall to discuss and brainstorm ideas for more "innovative worship." She also met with the Youth during worship to explore some of their ideas and how they could see themselves getting more involved with worship and the church in general. Some forty-five ideas came forward between these two groups, which staff and lay people have already started to implement.

### Here are a few we are already trying:

- use of more drama, readers' theatre, tableaux (Good Friday Advent)
- allowing congregational members to share their gifts and stories in worship time
- youth reading scripture (they read brilliantly on Christmas Eve)
- staying with a theme for worship/Sunday school for a period of time (Fruit of the Spirit – this fall)

#### There was also discussion of:

- more contemporary (up-beat), inclusive music, as well as classical
- Having different instruments accompany the singing ukulele, guitar more joyful singing
- Displaying artwork or congregational sharing from intergenerational services in the back of the sanctuary for all to see and read
- Possibility of having power-point where liturgy, hymns, images and videos could be used to support worship themes
- More interactive worship/message time

There are many possibilities for us to discuss and live in to, all of which will help us grow in faith, fellowship and ministry. Pretty soon we are also going to need to have the conversation as to how all of what we are, and what we do, will continue, in an aging building. Could the possibilities within, what some might consider being a problem, help us re-focus on living out our vision? What is really important? What are the priorities? How is God calling us to live into the vision we have? Who will get together to discuss the possibilities? Who has a sense of urgency in serving God and God's church? Or, do we continue to maintain, doing what we do and hope someone else will step up? I think we

have some pretty important conversations to have with ourselves and our God in this coming year. I pray you will consider stepping up to be a part of them.

God has helped us through much this year. Our Sunday worship numbers maintain stability and there is a continued interest in Baptism and spiritual growth opportunities. Our Sunday school is steady under the strong leadership of Jan Demeduk, and our fellowship interest group continues to entertain new ideas of welcoming newcomers. Finance, as always, remains its balanced course with Bill Craddock leading the way. The Sr. Choir, Junior Choir and small instrumental and voice ensembles lift our hearts and Spirits to new heights. The final musical selection in the Christmas Eve lessons and carols was magical, leaving the congregation to feel as if they were standing in a field of gentle falling snow. I hope there will be a repeat in the New Year, so others can enjoy the scenery the choir painted for the listeners. For all of these gifts of music we are grateful, under the careful direction of Derek Morphy and Wes Elias.

As you read the following pages, offer your own thanks to God and those who have been encouraged to grow, serve and empower others in the ministry and mission of God's church. We are not a perfect church; no church is, but we do have the power within to serve God with excellence both within and beyond her doors. I pray 2018 will be a year of discerning how we can engage more fully with the community around the church, and specifically our mission within it.

I offer my own thanks to my partner in ministry, Karen Lumley and our office administrator Andrea Moffatt, both of whom are continually patient with my lengthy process and study of all things church! Jeff Kremer has been a wonderful addition to our staff team. He has a wonderful eye for design and colour and his gentle touches are seen and felt throughout the upkeep of the building. Thank you all for your faithfulness to what God has called you to and for all you do to make this church a light in an increasingly dark world.

### From the Service Team (Board) Chair

Having been a member of St. Andrew's all my life, I have seen significant changes over the years. From what was once a gymnasium and is now the Christian Education building, to many important additions such as an elevator, a new piano and new furniture. My parents were married at St. Andrew's in the previous building located at Oak and Kingsway. However, many things have not changed. - Jeff Kremer for his caretaking efforts to ensure we have a clean and pleasant environment to worship in;
- Andrea Moffatt for her ability to operate the administration office and at the same time keep all of us on our toes to ensure we complete the tasks we have volunteered to carry out; and finally,
- I must whole heartedly thank all the volunteers in the congregation who work tirelessly over the year, from attending interest group meetings and performing their associated work, to the serving on the various fundraising activities that occur to ensure that St. Andrew's carries on for another century. I always have said that volunteers must be treated with kid gloves and I hope we are doing that for all of you.

During the year, some notable things took place:

- in December, the Service Team approved a ministry agreement be prepared and signed between St. Andrew's and Spirit Path;
- in November, the Service team did not approve Remit 6 (One New Order of Ministry), but they did approve Remit 3 (Office of Vocation) and Remit 4 (Funding a New Model) in May, as well as Remit 1 (Three Council Model) and Remit 2 (Elimination of Transfer and Settlement) in February;
- in October, there was an affirming workshop;
- the ABC group funded new sofas for the lounge; and

• an extension of the governance trial model was approved until August 2018.

I want to thank everyone for supporting me in my role as chair of the Service team at St. Andrew's. I know that there is always a lot of work to be done to make this amazing church function as it does, and I am so grateful to all of you for your contributions.

May God continue to bless St. Andrew's and lead us to serve the church in many more ways, and to serve the wider community.

### Treasurer's Report

Member givings in 2017 were significantly over budget (\$15,457) thanks to the generosity of many members. As was the case last year, we received some very much appreciated significant extra givings from several members.

Extraordinary repairs to our building was a factor in last year's significant deficit. This year. our building repairs were within a budget which was only 42% of what was spent last year.

Most revenue and expenditures in 2017 were close to our budget with the exception of member givings which were \$15,457 over budget. As a result, the projected deficit of \$17,707 turned out to be a **surplus of \$1,529!** 

(All revenue and expenses for the operating account are shown in Table 1.)

In addition to the operating account, our church maintains a number of other accounts which we label as allocated accounts. These accounts include all of the Guatemala missions, Anna Blair Circle, Right to Housing, and a number of others. In 2017, these accounts had total revenues of \$114,250 and expenses or disbursements of \$156,756. Part of the difference between revenue and expenses reflects the fact that the youth Guatemala Mission Experience took place in March.

Table 1 is a consolidated Income Statement for the operating account. Our complete balance sheet is in Table 2. It includes the ending balances for the allocated accounts and year-end balances for our assets and liabilities. (Details of individual investment holdings are available at the church office.)

The daily financial operations of the church are very much dependent on our investment income. The foundation and church investments contributed a total of \$58,000 to the Operating Account total revenue of \$446,610.

I believe that all of our financial statements accurately portray our church's financial position at year-end, and that our accounting procedures are in good order. The independent review this year is again being under taken by Howard Rempel, an accountant with a charitable organization.

It has been a privilege and an honour to again serve as your church treasurer throughout the past year.

### **Caring Community and Rose Ferries Prayer Shawl Ministry:**

The Caring Community is an interest group under the umbrella of Fellowship & Pastoral Care.

Our main purpose is to keep in touch (either by visit or by phone) with those who are homebound. We also send "Thinking of You" cards to those who are in hospital or are recuperating at home due to an illness or other medical problem. Sympathy cards are also sent to those who have suffered a bereavement. Also, Christmas cards are sent to those who are no longer able to attend our worship services.

In 2017, 24 "Thinking of You" cards were sent, as were 33 sympathy cards and 32 Christmas cards.

The cards we send are made by Colette Berriault and we receive many appreciative responses - not only for the card, but the message that is included on behalf of the congregation of St. Andrew's.

Our committee had a couple of changes this past year. Lorilee Leslie-Cole, our long time member and the person with the responsibility of sending cards, is no longer part of our church. We welcomed Ellen Bruneau who joined us and has assumed the role of sending the necessary cards.

On another positive note, Brenda Kennedy has returned to once again participate in the work we do. So, with her and Ellen on board, plus the rest of our wonderful committee, we are busy and very active.

Another decision has been made to change the criteria of those receiving Holy Week plants. This ministry was begun several years ago, whereby a plant is delivered, in person,

to the home of a family from St. Andrew's who has been bereaved in the past year. Those now receiving the plant will have lost a spouse, a parent, a child, a grandchild or a sibling. This means that 20 plants were delivered this past Easter rather than 37 if we had continued with the previous format.

The accompanying cards are handmade by Brenda Trevenen (a former office administrator at St. Andrew's)

On the subject of plants, a list of homebound, those in personal care homes or the hospital, is given annually to Ruth McKenzie. We also include the assisted living facilities. In this case, since most of the residents are mobile, one plant is given to the front desk for all to enjoy. The flowers and plants, which so beautifully decorate the church at Easter, are then taken to those whose names are on the list - again, by volunteers on their way home from Easter Sunday service.

One further thing to add - what would we ever do without the excellent communication and total involvement of our wonderful ministers - Cathy and Karen - and Andrea in the office. They notify us of all the incidents of health problems and/or bereavements, enabling us to send the appropriate cards.

As reported last year, our committee also has a group of knitters who supply the church with **Baptism Blankets**. These were introduced a couple of years ago and, as the title implies, are given to each baby baptized at St. Andrew's. This has been an overwhelming success and so appreciated by the parents.

The Rose Ferries Prayer Shawl Ministry continues to bring caring to those in need of comfort. Please remember that the shawls are not only for those in our congregation. If you know of anyone who would benefit from receiving a shawl, a visit to our church office will provide this for you.

Thank you to each member of the Caring Community for your support and dedication to the ministry we provide (Vinny Ashton, Ellen Bruneau, Bruce & Ardelia Burrow, Verla Cleland, Marjorie Eckert, Brenda Kennedy, Cathy Kinsman, Lara Kuzyk, Maxine Hannam, Karen Lumley, Andrea Moffatt, Roberta Popoff and Luba Scott). Keeping in contact with those who are no longer able to be with us for Sunday worship is vital for their connection with St. Andrew's and keeps them in touch with their faith community.

### St. Andrew's River Heights United Church Foundation

The St. Andrew's River Heights United Church Foundation was established in 1975 and was initially funded with funds derived from special gifts transferred over from the church in the original amount of \$12,217.63, and then added to with the sale of the church manses. Since its inception the foundation's assets have grown as a result of bequests, memorial gifts and donations. A minimum of 80% of the annual and/or accrued income derived from the foundation's investments is distributed annually to St. Andrew's River Heights United Church to be employed in the ongoing mission and work of the church.

Over the past many years, the foundation has been invested in a diversified portfolio, with the majority invested in fixed income investments such as money market funds, bonds and deposit notes. As at December 31, 2017, 63% of the market value of the foundation's assets were invested in fixed income or equivalent investments (comprised of Guaranteed Investment Certificates and provincial, municipal and corporate bonds ranging in duration from 1 to 6 years, and preferred shares) and with 36% being invested in equity mutual funds, common stocks, real estate trust units (comprised primarily of large cap Canadian companies, US and international growth and dividend funds and a Canadian real estate investment trust). The remaining balance, approximately 1%, was held in cash at December 31, 2017.

Over the past number of years, due to relatively high percentage of fixed income investments, the foundation's balance sheet and rate of return has been quite stable. The table below indicates the *approximate* market value of the Foundation \* (inclusive of accrued interest) as at December 31 in each of the past 5 years:

The market value of the foundation portfolio has moved up nicely in value over the past year due primarily to a few factors. Firstly, the portion of the portfolio, approximately 14%, invested in re-set preferred shares has recovered in value dramatically over the past year from where they had fallen to due to the anticipation of the re-setting of the dividend yields during a lower interest rate environment. One of the preferred shares we

own will re-set the yield this year, two in 2019 and the other two in 2020, so the preferred shares that re-set in 2019 and 2020 should continue to move up in value. We also still receive a very good dividend yield on the preferred shares. Secondly, the rate of return was very good, for a conservative portfolio, again this past year at 6.125%. Thirdly, the annual donations to the foundation have increased this past year, to \$8,479.00 up from \$2,921.20 in 2016.

The foundation's investment advisors (CIBC Wood Gundy) have confirmed that the annualized rates of return for the foundation investment portfolio as at December 31st, 2017 were as follows:

From 1998 to 12-2017	5.529%
01-2013 to 12-2017 (5 year)	4.993%
01-2015 to 12-2017 (3 year)	4.023%
01-2017 – 12-2017 (1 year)	6.125%

During the 2017 calendar year, foundation investments earned interest and dividend income of approximately \$35,500.00. This income covered the \$35,000.00 contributed from the Foundation to the operation of St. Andrew's Church during the 2017 calendar year. These contributions were paid during June and in early December 2017. During the 2018 calendar year, the foundation projects earnings will be slightly over \$35,000.00 on investments. At the foundation annual meeting held in November of 2017, the board committed to make a one-time larger gift of \$50,000.00 to the operation of the St. Andrew's during the 2018 calendar year. Audit costs and income tax filing costs for 2017 (payable in 2018) are anticipated to be in the neighborhood of \$4,000.00 plus taxes.

The specific gifts received by the foundation during 2017 are set forth in Schedule 'A' following this report, and were in the total amount of \$8,479.00. Once again, the foundation expresses sincere thanks to all who gave so generously to the foundation during the 2017 calendar year.

As chair, I would encourage all members of the church and other individuals or organizations who utilize the church building for the advancement of community objectives and activities, to make annual donations as well as planned gifts to the foundation. All gifts to the foundation receive a charitable donation tax receipt which reduces the out of pocket cost of the gift. It is particularly useful in estate planning to consider gifting registered investments such as an RRSP or RRIF to a charity (if such investments are not eligible to be 'rolled over' to a surviving spouse as beneficiary). In

situations where the registered investment cannot be gifted or 'rolled over' to a surviving spouse, the donor's estate will receive a significant reduction in tax that would otherwise be payable to Canada Revenue Agency upon collapse of the registered investment. Money that would otherwise go to Canada Revenue Agency may thereby find its way into the foundation to serve the broader purposes of the foundation and the church. Please speak with your investment advisor, accountant or lawyer for more information in planning your charitable estate gifts. Your gifts enable the Foundation to contribute financially to the ability of St. Andrew's River Heights United Church to serve both the community of faith within the church and the broader outreach work of The United Church of Canada. Gifts to the foundation truly are gifts that 'keep on giving' - while you are alive and after you have departed this world. The foundation encourages gifts made at any time during your lifetime or as a charitable bequest under your will or as a beneficiary of a life insurance policy. ### **Ministry and Personnel Report**

The Ministry & Personnel Interest Group is a confidential consultative body that supports the pastoral relationship. In the United Church, we describe ourselves as, "being in ministry together", recognizing that the work of the paid ministry personnel is only part of the work of the ministry. There are also a number of other staff positions for which the M&P Interest Group is responsible including the office manager, caretaker, choir director, organist and financial administrator.

Duties of the M&P Interest Group include:

- Provide a consultative and supportive agency
- Review working conditions and remuneration
- Oversee the relationship of staff members among themselves and with the congregation
- Conduct annual staff evaluations
- Review regularly the responsibilities of staff and revise position descriptions when required
- Monitor continuing education

As a committee we have three main areas of responsibility: Administration, Personnel and Ministry.

### **Administration**

Andrea Moffatt, our office manager, is responsible for organizing, coordinating, and supervising office operations and procedures. Andrea tracks membership, manages calendars, coordinates events and facility management and maintains an email database that enables electronic communication with our congregation and community partners. Her office hours are Monday to Friday, 9:00am to 3:00pm.

### **Personnel**

We continue to be supported by a group of talented and dedicated staff members.

Music is of great importance to our congregation. Our Director of Music, Derek Morphy, provides leadership in the ministry of music – most visibly through his direction of the senior and youth choirs. Wes Elias is our organist. In addition to providing accompaniment for hymns and anthems, Wes plays preludes, offertories and postludes as well as music for weddings and funerals.

As Financial Administrator and Treasurer, and reporting to the Finance Interest Group, Bill Craddock manages the financial affairs of St. Andrew's. For 40 years, Bill has served on many committees including the Service Team.

Jeff Kremer is under contract for cleaning and light maintenance work in the church building – a challenging task for a building that is 65 years old and in use most days from early in the morning until late in the evening.

### Ministry

Operating in a team ministry, Karen Lumley and Cathy Kinsman support the mission of St. Andrews. This is accomplished by their two distinct roles. Cathy's priorities are worship with a focus on preaching and sacraments, in addition to pastoral care and adult education. Karen's focus is Christian education, youth programs, outreach, and pastoral care. We are very fortunate to have two highly respected and gifted individuals ministering in our community.

The M&P Interest Group would also like to offer a special thank you to the St. Andrew's team of volunteers for the many hours spent performing countless tasks and projects.

### **Outreach Report**

St. Andrews has continued to be actively involved in outreach opportunities as they have arisen, and our group is currently identifying our priorities for 2018. We support several ministries – North End Stella Mission, St. Matthew's Maryland Ministry, West Broadway Community Ministry, Rainbow Ministry, Siloam Mission, Agape Table and Oak Table.

In February, items were collected for S.N.O.W. Night (Safe Night Off Winnipeg Streets), that offers support in a non-judgmental manner for women who are involved in the sex trade.

Several members also attended St. Matthew's Maryland Café as an opportunity to become acquainted with community members for whom St. Matthew's Maryland plays an important role.

Several members signed up to sort clothes at Siloam Mission, and we also supported the Good Night's Sleep project at St. Augustine Church with a donation.

In May, the group cooked hams and attended the community feast at "Meet Me at the Bell Tower". The feast and gathering was held in support of creating a healing space in St. John's Park. This was another opportunity to become acquainted with the community with whom "Meet Me at the Bell Tower" and Michael Champaign play an important role.

The weekend of June 23/24, our group attended events at the Assiniboia School Reunion. We volunteered to serve food at the Friday night dinner. This event was well attended and well received by those who attended. It was an opportunity for us to gain some understanding of the impact that residential schools had on our indigenous community, and how that still has an impact today.

Names were submitted for Circles of Reconciliation, which will begin soon. These circles for discussion consist of five members of St. Andrew's meeting weekly with five indigenous participants, as an opportunity to develop better understanding and acceptance.

In December, we supported the postcard campaign for Bill C262, to be sure that all of our laws are in harmony with the UN Declaration of Independence.

The Mitten Tree was again set-up to collect knitted toques and scarves and good quality waterproof mittens for those in need.

Priorities for the Outreach Interest Group have been discussed and identified at meetings in November and December.

Meals on Wheels is an ongoing part of outreach, which is coordinated by Bruce and Ardelia Burrows. Many thanks to them and their dedicated team of volunteers. (Ardelia has submitted her report separately.)

Thank you to all of the volunteers who have participated in the many outreach opportunities this past year.

### **Meals on Wheels:**

For well over 50 years, St. Andrew's River Heights United Church has been responsible for coordinating Route 4 for the Meals on Wheels out of the Misericordia Hospital.

We are very fortunate to have the route covered every Thursday and Friday each month, while another group staffs the route two Tuesdays per month.

We, then, require our spares to help us every Monday, two or three Tuesdays a month, every Wednesday and, of course, when there are holidays, illnesses or other situations where our regulars are unable to do the route.

No one - except for our volunteers who do the route on a weekly basis - is scheduled to staff the route more than 3 or 4 times over a two month period. The approximately 10 meals to be delivered are picked up from the hospital around 11:00am, and we usually return to the hospital around noon, so it is not a huge time commitment.

As we have mentioned previously, we have an extremely enthusiastic group of volunteers, most of whom are a part of St. Andrew's. This is a very meaningful and rewarding volunteerism and our job is made so much easier by the willingness and dependability of all who are a part of this organization. ### **Property and Administration Report**

Thankfully, the year 2017 concluded without major issues with the heating system, plumbing network, or roofing integrity. Thus the overall repair bill was significantly less than in 2016.

That said, however, maintenance expenses were still significant, reflecting the aging infrastructure of the building, and indicating an ongoing need for substantial maintenance budgets.

In particular, the heating system required several visits (in addition to the routine maintenance schedule) from our service contractor to address radiator leaks, steam trap malfunctions, temperature control deficiencies, and so on. Plumbing services were also required, though several minor water issues were handled internally by Jeff Kremer, our

building manager. Roof leaks were less apparent than in recent years, though this may have been due more to a dry year in Winnipeg than to anything else. We remain anxious about the deteriorating state of the flat roof on the northwest corner of the building but hope that regular annual inspections and necessary patching will keep it more or less watertight for a few more years.

As a general observation, the interest group continues to be very concerned about the likelihood of heating, plumbing and roofing emergencies, and the need for possibly major expenditures to remedy these when they occur. While recognizing the tight operating budget of the church, the committee would like to see provision for funding the extensive infrastructure updates that will certainly be necessary in the not-too-distant future.

During the year your property interest group comprised Bob Barr, Murray Cameron, Bruce Scott, Gord Shawcross, Hartley Stinson, John Swan, Sue Wiste and Dave Wreford, with Jeff Kremer providing valuable back-up. All shared in carrying out the committee's many responsibilities, with Gord and John in particular doing much of the "heavy lifting". Ten regular monthly meetings were held, along with informal consultations between some members to deal with special situations as they arose from time to time. To name a few areas of responsibility, in no particular order of importance or time/personnel requirement:

- Identifying and labeling electrical outlets with reference to their respective circuit breakers, adding additional electrical outlets, and arranging for replacement of electrical panel "G".
- Liaising with long-term renters, arranging building opening/closing etc. with congregational groups and occasional renters, and performing evening 'walk-around" security checks.
- Responding to mice and silverfish infestations in the daycare/nursery areas.
- Liaising with the snow-removal contractor.
- Patching and painting damaged walls, painting external metal railings, and repairing delaminating wooden doors in narthex.
- Repairing stone steps at south end of the building.
- Ongoing review and renewal of insurance policies.
- Arranging replacement of most remaining old wooden trestle tables with new plastic units.
- Removal and sale of 8 pews from rear of sanctuary plus relocation of others to create a mingling/coffee area under the balcony.

- Replacement (with new safety glass) of hazardous cracked glass partitions between narthex and sanctuary.
- Continued replacement of incandescent light bulbs with fluorescent and LED bulbs.
- Streamlining and digitalizing record-keeping and purchase-order procedures.
- Keeping meeting minutes and maintaining job-priority lists.
- Regular checking of defibrillation package and first-aid kits.
- Trimming of trees, care of grass and general tidying-up around building perimeter.
- Minor mechanical projects, for example replacement of a defective sump pump in the sub-basement (thereby avoiding a sizeable bill from external contractors).
- Ongoing stripping and re-waxing of floor tiles in heavily trafficked areas.

In conclusion, the interest group would like to thank our congregation for their support and patience as we work through the sometimes frustrating inconveniences and delays associated with keeping our elderly building more or less functional.

# Winnipeg Presbytery – Highlights of 2017

January – Our General Meeting was held at The United Church in Meadowood with cohosts of the meeting being Trinity United Church, Charleswood United Church, McClure United Church and Oak Table Community Ministry. Judy Hare, the Personnel Minister from The Conference of Manitoba & Northwestern Ontario, presented information contained in the Ethical Standards & Standards of Practice Document and The Manual regarding professional conduct. Winnipeg Presbytery also approved a motion to recommend the CDI Draft Investment Policy to The Conference of Manitoba & Northwestern Ontario, for implementation January 1, 2017.

**February** – The General Meeting was held at Westworth United Church with co-hosts of the meeting being Harrow United Church, Fort Garry United Church and Crescent Fort Rouge United Church. The General Council Commissioners (Patrick Woodbeck, Tim Crouch and Bill Millar) presented background information on Remit #4: Funding a New Model. The court listened to a presentation given by Raymond Currie and Belinda Vanden Broeck on Circles for Reconciliation.

March – Our General Meeting was an all-day meeting held at Sturgeon Creek United Church with co-hosts of the meeting being Crestview United Church, Kirkfield Park United Church, Silver Heights United Church, St. Charles United Church and Headingley United Church. Members from Augustine United Church gave a presentation on their future

development initiative – Augustine Centre. We also heard from 1JustCity, who is working towards becoming incorporated. The TRC Response Group invited Raymond Currie, who presented more information on Circles for Reconciliation and encouraged all to participate. After the presentation, Winnipeg Presbytery passed a motion of support for Circles for Reconciliation.

May - The May General Meeting was held at Broadway Disciples United Church with cohosts of the meeting being Knox United Church, Young United Church, Augustine United Church and West Broadway Community Ministry. Approval was given for the amalgamation of Northend Stella Community Ministry and 1JustCity. Kathryn Hofley, Financial Development Officer, presented the 'Called to be the Church Giving Program'. Winnipeg Presbytery agreed to become a Signatory to the Winnipeg Indigenous Accord on June 20, 2017, after receiving an invitation from Winnipeg Mayor Brian Bowman. Remit #4: Funding a New Model, was voted on and passed by the court.

June – Our General Meeting was held at St. Andrew's River Heights United Church with co-hosts of the meeting being Atlantic-Garden City United Church, Sparling United Church, Kildonan United Church and Fred Douglas Lodge. In a motion, the court recommended Patrick Woodbeck to The Conference of Manitoba & Northwestern Ontario for Ordination. We recognized Cole Grambo, who was going to Selkirk Presbytery and Connie Budd, who was leaving North End Stella Community Ministry. We acknowledged the following retirees – Dawn Ballantine-Dickson, Robert Campbell, Bruce Faurschou and Nancy Sanders.

**September** – The General Meeting was held at Crestview United Church with the cohosts of the meeting being Sturgeon Creek United Church, Kirkfield Park United Church, Silver Heights United Church, St. Charles United Church and Headingley United Church. The TRC Response Group put forward an endorsement of a campaign started by the Mennonite Church called Let's Walk the Talk Campaign, which promoted awareness of Bill C-262. After a presentation on the history of Spirit Path, Winnipeg Presbytery voted in favour of its continuation. Loraine MacKenzie Shepherd was installed as the new Presbytery Chair.

October – Our General Meeting was held at St. Mary's Road United Church with co-hosts of the meeting being Churchill Park United Church, Korean United Church and St. Matthew-Maryland Community Ministry. The 2018 Mission & Service (M&S) Fund Block Grant was approved. A panel discussion on Remit 6: One Order of Ministry took place. Table talk time was devoted to discussing the United Church regional boundaries.

Questions and concerns from the table groups were forwarded to the Boundaries Commission.

**November** – The General Meeting was held at Windsor Park United Church with co-hosts of the meeting being Transcona Memorial United Church, Grey Street United Church and Westminster United Church. Winnipeg Presbytery confirmed its ongoing support for fund development of 1JustCity. Remit #6: One Order of Ministry was voted on and defeated. CDI presented a summary of proposed changes to the CDI Loans and Grants Policies and the application form used for these funds. It was decided that Winnipeg Presbytery would provide Christmas presents for God's Lake Narrows again in 2017 with help from individuals and churches donating towards these gifts.

# St. Andrew's River Heights United Church Annual General Meeting February 26, 2017

Attendance: 80

- 1. Call to order and declaration of quorum. Chair Joan Stevenson called the meeting to order at 12:10 pm followed by a declaration that a quorum had been attained.
- **2. Opening Prayer and Time of Remembrance.** Cathy Kinsman opened the meeting with prayer.

Those present were asked to reflect & remember as Cathy Kinsman and Karen Lumley read out the names of those whose funerals were conducted during the past year at St. Andrew's.

- **3. Motion to allow adherents to vote**. **Moved**: Linda Paul/Rita Swan that adherents be permitted to vote during this meeting. **Carried**
- 4. Motion to accept the Agenda. Moved: John Barber/Kelly McKeag that the agenda is accepted with one correction under Finance report: the item "2016 budget" should read "2017 budget." Carried
- **5. Motion to accept minutes. Moved**: Glen Neufeld/Bob Barr that the minutes of the Annual General Meeting, February 21, 2016 are accepted as presented. **Carried**
- **6. Acceptance of Interest Group Reports. Motion:** Diane Bewell/Bill Muir that the Interest Group reports are accepted as presented. **Carried**
- 7. Report of the Chair of the Service Team.
  - In addition to her report, Joan Stevenson commented on:
    - her gratitude to our ministerial team, Cathy and Karen, as well as our music leaders, Derek and Wes
    - the new governance model which is being used on a trial basis. Joan acknowledged all of the official interest groups for their support throughout this process.
    - her appreciation of two interest group leaders, Bill Craddock and Gord Shawcross, for their dedication to overseeing the church finances and property
    - the resurgence of the Stewardship team

- o the continued work of the Affirming group
- the centennial book which continues to be worked on by Iris McKay and Josh Beaumont
- the new piano which was acquired in the last year. Joan thanked everyone for making this possible.
- Joan then introduced members of the Service Team, leaders of the Official Interest Groups, and members of the Board of Trustees.

#### 8. Governance working model review. Rob Siddall (full report, page 34)

- At the 2016 AGM, the board announced it would be following a new governance model on an interim basis for two years. Some of the changes include: the Board is now the Service Team; Committees are now Interest Groups; the number of members on the Service Team has been reduced; the terms of the vice-chair and past chair have been reduced from two years to one year; the method by which Interest Groups report to the Service Team has been modified.
- A survey soliciting feedback on the governance working model was recently distributed to all Service Team members and Interest Group chairs. The majority of respondents felt that the new model is working well overall. One area which could be improved upon is communication between the Interest Groups and the Service Team.
- A report on the governance working model will be presented at the 2018 AGM, at which point there will be a vote on whether or not to adopt the model on a continual basis.

# 9. Foundation Report. Deborah Metcalfe (full report, page 30)

- Members of the Board of the Foundation: Rev. Karen Lumley, Rev. Cathy Kinsman, David Wreford, Bill Craddock, Deborah Metcalfe, Joan Stevenson, Ross Johnston, Tom Brown, John Barber and Rob Siddall.
- Deborah Metcalfe encouraged members of St. Andrew's River Heights United Church and other individuals or organizations who utilize the church to make annual donations to the Foundation.
- As Chair of the Board of the Foundation, Deborah thanked the members of the board for their valuable assistance.

The following question was raised: why does the Foundation continue to hire

Frostiak & Leslie Chartered Professional Accountants Inc. for its annual audit, while our church has ceased to do so due to the expense for its own finances? Deborah responded that while our church does not legally need to be audited, the Foundation does require a full-scale audit. Deborah also explained that when compared to quotes provided by other accounting firms, the cost of using Frostiak & Leslie is not any higher.

#### **10. Finance Reports.** Paul Webster/Bill Craddock

- **a. Independent Reviewer's Statement:** Bill Craddock reported that the statement of the financial position of St. Andrew's for the year ending December 31, 2016 has been reviewed by Howard Rempel, an accountant with a charitable organization.
- **b. Finance Report:** (full report, page 13)
  - Givings were only slightly under budget, and were the third-highest ever
  - Most expenses other than maintenance and repairs were under budget
  - Investment income and fundraising revenue were under budget
  - We ended the year with a deficit of \$38,565
- **c. Presentation of 2017 Budget:** Bill Craddock presented the budget for 2017. The following was noted:
  - The budget projects a deficit of \$17,707
  - Projected givings are slightly lower than in 2016 despite many people pledging an increase in their offerings. This is due to the fact that people pass away, move, etc.
  - Maintenance and repair expenses are projected to be 40% lower than in 2016
  - Salaries have been increased by 1%
  - Mission & Service contributions have been reduced to 4% of regular offerings
  - The deficit situation indicates that our current model is not sustainable. The Service Team has asked the Finance Interest Group to develop a plan of action to address the deficit issues.
  - Our lease agreements with the daycare and nursery are scheduled to be renewed in the summer of 2018. The Property & Administration Interest Group has transferred responsibility for negotiating the contracts to the Finance Interest Group.

- Bill Craddock stated his confidence that we will be able to solve the financial issues and proposed to accept the 2017 budget.
  - i. It was noted that consideration will be given to whether or not the ministerial complement is in need of any changes. The Finance Interest Groups has no details at this time.
  - ii. It was noted that the cumulative deficit between 2012 and the end of 2017 (projected) will be nearly \$99,000. It was asked, to whom do we owe this money? Bill explained that it is not owed to anyone because we have always had retained earnings to draw from at the end of each year. If we end the year 2017 on budget, it will be the first year that we have negative retained earnings.
  - iii. A question was asked regarding how long it will take for the Finance Interest Group to develop a plan to address the deficit situation. It is expected that this will take place over the course of 4–6 months. It is not known when it will be reported back to the congregation.

**Moved:** Bill Craddock/John Swan that the congregation accept the Operating Budget as written for the year 2017. **Carried** 

### 11. Nominating Report. Linda Paul (full report, page 38)

- The members of the Nominating Interest Group are: Linda Paul, Joan Stevenson, Paul Webster, and Clark Brownlee. The ministers, Cathy Kinsman and Karen Lumley, act as resources to the committee.
- Linda reported that there was consensus to reduce the terms of both the vice-chair and past chair from two years to one year. This is intended to make it easier for people to serve in these positions.
