## 5. M & P Statement on Conflict Resolution (draft)

Michael Duncan presented the revised statement on Conflict Resolution. It was modelled on other UC models. After a discussion it was moved by Michael Duncan/seconded by Lorne Hurst that the Statement on Conflict on Conflict Resolution be accepted as presented. Carried.

#### **Items for Decision**

1. Governance Report: Ellen Peel and Joan Stevenson entered the meeting at 8PM for the Governance report. Ellen walked the ST through the various aspects of the report. A lengthy discussion followed. Ellen and other Governance IG members reported on the findings of the evaluation that was undertaken in the fall. The two issues raised by many of the respondents were that of communication and terminology. The GG recommends that the ST move forward with approving the Interim model such that it can become the permanent Model. This will require a review of the current Constitution and Regulations Documents. A final decision about whether to proceed with making the Interim Model permanent will be made at the February ST Meeting. The Congregation can then be informed of the decision at the AGM.
