#### **MINUTES**

1. Call to Order: Greetings/Vision Statement

- 3. Approval of April 15, 2025 minutes: Eliminate sentence "This will decrease the cost per copy but increase the annual cost by 7.5%" from the Treasurer's Report. Bill moves the minutes are accepted as amended; Lorilee seconds. All in favour.

## 4. Church Groups:

- Presentation Fellowship: Betty Jubinville shared a very informative presentation and update from the Fellowship and Caring Community Interest Group - see report; the hard work, dedication and support this group brings to the St. Andrew's community is very appreciated and does not go unnoticed.
- Other Group Liaison Updates:
  - Stewardship: Glenn informs us that there have been short, informational notes added to the bulletin each week to outline key aspects of the Church's finances for the congregation to consider. These will continue to be featured through the end of June.

- Ohoir Executive: Lorilee shared that the Choir Executive met April 27<sup>th</sup> and were busy working on the 100<sup>th</sup> anniversary concert. They have formed an Ad Hoc committee to go over the Choir's constitution this fall, the first time it has been examined in possibly 20 years. There was a hope that new name tags for the choir could be acquired, and it was suggested that perhaps we could feature choir members in the bulletin/E-News to help the congregation get to know the choir, especially the new members.
- M&P update: Rob An outline of the role of the M&P Group has been prepared, but it is primarily information from the United Church of Canada and not necessarily tailored to St Andrew's. The current St Andrew's Terms of Reference for the M&P Group was sent to the 3 members and the plan is for them to meet soon and start without a chair. Rob will keep in touch with the Group.

- 5. Minister's Report: Karen No official report but Karen is very busy as always; she would like to encourage congregants to add their input to the UCC timeline being created for the 100<sup>th</sup> anniversary by Westworth United.
- 6. Rental Policy Update: Rob It has been agreed that the staff use of the church premises is not the concern, provided that there are no costs to the Church, but rather the concern is the reasonable likelihood of the loss of potential rental income. Rob will collect further information.
- 8. Succession Planning: Rob Looking one to two years into the future, it is agreed that filling the next Treasurer's position is most logical by splitting it into 2 roles: a bookkeeper to record, account for and allocate church revenue and expenses to their proper accounts, to prepare cheques for signing by the Treasurer and to prepare preliminary budgets; and a Treasurer to oversee the bookkeeper, to sign cheques, to make bank deposits, to finalize budgets, to deal with other substantive issues as they arise and sit on Council; it may be wise to start thoughts on this matter and

possibly hire the bookkeeper sooner to take the weight off from Bill and allow more time for him to train the new bookkeeper and Treasurer.

9. Treasurer's Report: Bill presented a summary of the Profits and Loss Budget vs Actual for January to April 2025. Everything is in line overall and as expected. Donations are coming in steadily and income remains strong from rentals. Income is up over the budget so far, but replacing tiles in the daycare has also put us over budget for building repairs.
